Positive Coronavirus Cases in USA Pass 4.5 Million!

As of July 31, Florida has reached 470,386 cases since the pandemic began, and we have lost 6,843 residents. Pasco County has had 6,299 cases, 16th highest in the state. 1,457 of those are in New Port Richey.

Message from Tall Pines Board of Directors

As you all know, the Board has been unable to meet in person since February, due to COVID-19 restrictions. However, there has been quite a bit of activity, of which residents may not be aware, going on behind the scenes. Much of this would normally be reported at board meetings or within the minutes, so we thought we would provide you a short synopsis of some of this activity.

- *The street ownership issue within Hunt Ridge has been finalized, and the deed is now recorded in the name of TPCA. This allows us to now legally maintain those affected streets and sidewalks.
- *There have been multiple requests regarding tree issues over the past several months. Several trees have been inspected, and dead branches or dead trees were removed.
- *An issue with the pump for Well 10 was repaired by replacing a control box.
- *The issue on the curb on LaQuinta Drive where there was some erosion was repaired by the vendor.
- *The contact list on the Tall Pines website was updated by our webmaster, and a breakdown of HOA fees was added.
- *Two new stop signs were added within Valley Wood as requested by their board.
- *Concrete donuts were added to all street signs in addition to them being straightened.
- *Multiple pond water quality issues were submitted to our pond service vendor.
- *A request was submitted to WREC to address an electrical box in Valley Wood which appeared to be sliding off the platform.
- *A request was opened with the Post Office asking them to inspect several multifamily mailboxes which are in poor condition to see if they qualify for replacement by USPS.
- *A walkthrough was performed on the Ruxton II sprinkler system to assess issues reported by their board.

The above is just a sampling of some of the items that have been taken care of on behalf of the association. There are many other items which are still being addressed.

In March, we unfortunately needed to lock the clubhouse due to COVID-19 and the liability that it presented to the association. We continue to reassess this as new guidelines are released by the government, and we consult with our management company, and in some cases an attorney, for guidance. As soon as we are presented with guidelines which will allow us to safely reopen without causing a liability to the association, we will advise residents. It does appear that there will be several steps which we will be required to take that will be an additional expense to the association, including regular sanitation and adding hand sanitizer stations, etc.

However, even though the clubhouse remains closed until further notice, we have continued to have it inspected once a week by a board member to ensure that there are no leaks or issues which would cause any sort of damage.

During the time that the clubhouse has been closed, we repaired one of the toilet seals. We also have had the seven air conditioning units cleaned and serviced as we do every six months. We had some faulty dimmer switches replaced. We also had the storage building next to the clubhouse repainted and the roof repaired. We will continue to maintain the building so that it is in tip top shape when it reopens to residents.

SPRINKLER SYSTEM PROBLEMS

Gary is in charge of the **sprinkler system** for all Tall Pines neighborhoods. YOU MUST CALL PARKLANE REALTY SERVICES at 727-232-1173 to report the issue. Each case will be assigned a work ticket number, and Gary will respond to them in order. Any sprinkler problem can be reported...i.e, buried, not functioning, needing to be directed away from your home in order to avoid rust stains**, etc. Gary will take care of the problem.

**Try "The Works" from the Dollar Tree or WalMart to remove rust stains easily from your white stucco. Squirt on. Wait. Rinse off.

ALL OTHER YARD PROBLEMS






