Drainage in Cluster Homes; Recent Flooding

We have many "Cluster" Homes in Tall Pines. These are the quad units with garages where the entrances

all face to opposite corners of the building. These are mostly in Ruxton, Ruxton II and Spring Lake. The center of these buildings all join with a courtyard, also sometimes called an atrium, separated from their neighbors with a wall and containing a screened top to allow light in.

We have had quite a bit of rain recently, and it was reported that **several cluster homes took rain inside the home from the courtyard.** We wanted to share some information with those who own one of these types of homes and are long established here and those who may be newer to the neighborhoods. Many may be unaware of the drainage system present in these units.



Within these courtyards, there is a drain in the corner to allow the rainwater to drain out. The location of the other end of that drain (the output) varies depending on the home. The builder's design was to drain those courtyards to a box in the middle of the lawns. However, over the years, some residents have chosen to have the drain extended to near their driveways or near the streets, where the output would be at a lower grade and allow the water to flow out more easily. In one instance we are aware of, a homeowner had a sump pump installed in their courtyard rather than having the drain rerouted. It is the homeowner's responsibility to keep those drains cleaned out on a regular basis to keep them free of debris, weeds, etc which would cause water to either drain slowly or not at all. If you are experiencing water not properly draining in your courtyard, you may want to have a plumber out to snake that line and perhaps reroute to the output to a lower area on your lawn.

Irrigation System & Mailbox Issues

There seems to be some confusion on who to call when you have irrigation problems. **You need to call Parklane Real Estate Company at 727-232-1173** (management company for Tall Pines). They will generate a work order ticket for Gary, who will respond and fix your problem. Let them know if it is an emergency.

There have been instances where the management company for Hunt Ridge, Management & Associates, has given inaccurate information about how to handle irrigation problems. Hunt Ridge, Valley Wood, Spring Lake, Ruxton Village and Ruxton II, all must call Parklane for irrigation problems.

We have also had questions about who to call with **mailbox** issues. Remember it is your mailbox and you are responsible for any repairs. If you open the mailbox door, you will see a tag with the phone number of the manufacturer. You can order any parts through them.

VANDALISM & THEFT IN NEW PORT RICHEY, TRINITY AREA

Residents must stay vigilant in the wake of recent vehicle thefts, tire slashing, and more. Twenty neighborhoods have recently been targeted, at times 4-6 subdivisions per night, with cars being ransacked and stolen. In Tall Pines, there has been a car theft and tire slashings recently.

Residents are being warned not to approach the offenders, but to CALL 911. Residents are, however, encouraged to share information on social media, such as Nextdoor and facebook.

There are a number of cameras that can be installed. Nest, Blink, and Arlo are some. The police will view footage on these types of devices if they are called for a complaint.

MONTHLY INSPECTIONS Parklane Real Estate Services is conducting monthly inspections for violations. Please tend to your property so as to avoid violation notices. Please remember that board members are volunteering their time. All violations unnecessarily take up their personal time, as well add to our monthly Parklane Real Estate Services cost for "consumables" – for letters, mailing, and attorney fees.

Due to continuing non-compliance, the board has begun utilizing the Fines Committee. After non-compliance notices, and a hearing, our documents allow successive daily fines up to a maximum of \$1000.

We thank the **vast majority** of Valley Wood villa owners for abiding by the rules and regulations, maintaining beautiful lots, keeping our property values up, and taking great pride in our neighborhood.

And... we thank those owners recently taking corrective action to a received violation notice.

SPRINKLER SYSTEM PROBLEMS

Gary is in charge of the **sprinkler system** for all Tall Pines neighborhoods. YOU MUST CALL PARKLANE REALTY SERVICES at 727-232-1173 to report the issue. **Indicate if it is emergent i.e. running or spraying water.** Each case will be assigned a work ticket number, and Gary will respond to them in order, **except if it is an emergency.** Any sprinkler problem can be reported...i.e, buried, not functioning, needing to be directed away from your home in order to avoid rust stains**, etc. Gary will take care of the problem.

**Try "The Works" from the Dollar Tree or WalMart to remove rust stains easily from your white stucco. Squirt on. Wait. Rinse off.

ALL OTHER YARD PROBLEMS

With the exception of Ruxton II, and Hunt Ridge, all neighborhoods should report other yard problems to **Parklane Realtor Services** at **(727) 232 - 1173.** Ask for Dora Steed.

Ruxton II residents should call **Ameri-tech Realty Inc**. at (727) 726 - 8000.

Hunt Ridge residents should contact Management & Associates at (813) 433-2000

CRIME WATCH

If you see something of concern, don't approach any person suspected of criminal activity. Take visual notes and call 911. Please do not intervene yourself.

TREE OWNERSHIP

If you feel that there is an issue with a particular tree near your home, the ownership of the tree needs to be determined to know whether the responsibility would lie with the homeowner or the association. In order to determine if a particular tree belongs to you or Tall Pines, contact Parklane Realty Services to document your concern. Parklane will then contact the Tall Pines board.






