We have an email distribution list which we utilize to send important community information. Our community newsletter only comes out once a month, and sometimes things pop up in between issues, and we feel the community might need or like to know about them. Note that we try very hard to limit our email communications so that residents do not feel burdened by too many emails as we do not ever want residents to feel we are bombarding them.

However, we have 317 homes in the community and we only have email addresses for about 30% of the residents which means the majority of you are missing those important notifications. We would like to be able to reach more Tall Pines residents. Both homeowners and renters are eligible to sign up for this distribution list.

Please visit the **Document section** of **www.tallpinesnpr.com** for all forms. You can find a copy of the Resident Profile Contact Form there. We will include a copies of this form in the printed & delivered November Hi Lites issue, for those who may not have a printer available. Just fill it out, and drop in the box at the front door of the clubhouse.

In addition to collecting email addresses for our distribution list, we also want to remind all homeowners that there is a Consent to Electronic Delivery form on our website. This form is **for owners only**, not renters.

According to Florida State law, the association is required to send certain types of notices via hard copies through the USPS unless the owner has given written consent to receive notices via electronic transmission. These mailings come at a great cost, which ultimately is paid for by us, the homeowners.

If you are willing to receive those notices by email rather than hard copies, you can find the form here: www.tallpinesnpr.com and you may insert it into the drop box at the front of the clubhouse.

It is important to note that filling out a contact form to allow you to receive community information **is not the same** as filling out the Consent to Electronic Delivery. If you wish <u>all</u> information to come via email, you need to fill both forms out.

#### ARE YOUR SPRINKLERS NOT WORKING?

<u>Please report this immediately via the website contact form.</u>

We have received several requests recently where residents are stating that they feel they haven't had water for weeks or months, but no requests have been submitted.

We need these reported immediately so they can be put on the work list to be repaired. The best person to report this is the homeowner or resident who sees it every day. We rely on you reporting issues that you notice.

Note: It was recently reported that some of the dead lawns were caused by Chinch Bugs rather than lack of water/irrigation. If you have a concern that Chinch Bugs may have damaged your lawn, please speak to your sub association so that their board can have the contracted pest company check and treat this properly.

#### PARKING ON THE GRASS — NEW SIGNS HAVE BEEN INSTALLED

There have been increased reports of cars parking on the grass, both in common areas and with-in yards.

Please know that our bylaws specifically state that there is to be no parking on the grass within the entire community.

We have a very old, fragile irrigation system which can be damaged by the weight of vehicles, additionally it damages the lawns.

IF YOU CHOOSE TO PARK ON THE GRASS, YOU RISK BEING TOWED! And the cost of a tow can run as much as \$500 out of your own pocket, so please do not park vehicles on the grass anywhere in the community!

**Proof Of Notice:** On the website, via email, and on signs posted at Tall Pines entrances.

#### **Announcements/Accomplishments:**

- **1.** Reminder to hold questions and comments until end of meeting.
- 2. The clubhouse parking lot is being resealed on 10/23/25, there will be no driving and the front drive will be blocked. Cars must go down Brookhaven rather than across the front of the clubhouse. There will be no guest parking for 2 days while the sealant dries.
- **3.** Use the contact form on the website, report PROMPTLY regarding trees/landscaping, irrigation, management.
- **4.** Reminder that the Hi Lites is not delivered during the summer but it is available year-round on the Tall Pines website. Watch for important community news and events, it is always published the first week of the month.
- **5.** We need a volunteer to be backup editor and eventually take over. If we do not find a volunteer, we are at risk of not having a community newsletter.
- **6.** We are still looking for volunteers to help collect info and create a new Community Directory, last one was done in 2019. If we do not get volunteers, this project will not occur.
- 7. Reminder that there is a game night on Wednesdays, card games, etc. See HiLites or Patrycja for more details.
- **8.** If anyone would like to create other activities open to all residents (exercise class, etc.), please see Patrycja for availability. As long as an event is open to the entire community, the clubhouse is free to use for owners of Tall Pines.

**Secretary's Report:** Jill made a motion to waive the reading of the previous month's minutes, 2<sup>nd</sup> by Carolyn, all in favor, motion carried.

#### **Treasurer's Report:**

Monthly income was 20,973, monthly operating expenses were 20,244 (over budget by 5,363), reserve funding was 6,271, monthly operating deficit of 5,414

(due to unusually large costs for irrigation, legal fees, electricity, and lack of advertising income), year to date income was 150,000, year to date operating expenses 113,000,

Year to date reserve funding 43,000, year to date operating deficit of 6,623, general operating account 965, petty cash 585, total reserve funds of 439,536.

#### **Property Manager's Report:**

Brett reported that financials were mailed out on 10/15/25, weekly inspections took place on Tuesdays, homeowner concerns were irrigation.

Tree quotes - discussed in landscaping part of agenda. There was considerable discussion on HVAC cleaning quotes, how many times per year it is needed, etc. It was decided to table this item until we get a quote from Johnny Cool for cleaning two times per year. Brett reported that a new management contract with Tall Pines has been signed, and that it is for one year. Regarding quotes for the CO2/smoke detector system being planned, Brett is awaiting written quotes.

#### **Old Business:**

- 1. Status of Baltusrol Flooding Issue / Legal Issue Charlie reported that total expenses through 9/30/25 are 62,307. Regarding the inspection of the drain at the expense of Pasco County, they found and fixed a damaged portion of the drain pipe. They also cleared the vegetation and debris at the outflow basin in Gracewood, resulting in the drain currently being in pristine condition. We are now in negotiation with the County to give them perpetual right to maintain the drain from our part of the system. They also need to negotiate a similar agreement with Gracewood to keep the outflow basin clean. The third agreement needed is between Gracewood and Tall Pines, which is a settlement agreement. Once these are in place, the lawsuit will be withdrawn to finalize the issue. Meanwhile, we will continue to encounter legal fees until these agreements are finalized.
- **2. Irrigation Update** Jill reported that we are getting a new breaker box on Baltusrol on Tuesday, October 21 because the old one is deteriorating and needs replacing.

#### 3. Landscaping:

- **A.** Common area cleanup Jill received a bid from Green Thumb for 1,200. Patty made a motion to accept this bid, Bruce 2<sup>nd</sup>, all in favor, motion carried.
- **B.** Tree list is started, and we have 2 bids so far. Florida Cuts is the lower of the two, at 2,790. We will get a 3<sup>rd</sup> bid from Pasco Tree. Patty made a motion to go with Florida Cuts at 2,790, unless Pasco Tree comes in lower. Judith 2<sup>nd</sup> this motion, all in favor, motion carried.
- C. Jill contacted Pasco County and got them to agree to remove two trees leaning towards Vale Loop.

- **4.** Clubhouse Air Conditioner Maintenance This was discussed earlier in the agenda.
- **5. Fire Suppression** This was also discussed earlier in the agenda, and Brett is working on this.
- **6.** We still need a volunteer to monitor the website to ensure the correct documents are listed monthly.
- 7. Have All Board Members Gotten A Top Lock Key To The Clubhouse Entrance Door? Both Bruce and Judith indicted that they still need one, so they will get one.

#### **New Business:**

- 1. We Will Be Mailing A Required Package For Budget Soon. We will use this opportunity to include additional info like an Owner Profile, and a letter calling for volunteers.
- 2. Suncoast News Irrigation Checkup Free By UF Extension Carolyn checked into this, and she reported that this is for individual homeowners to receive this free irrigation checkup, not a system-wide checkup. Our current irrigation contractor covers many of the things that are routinely covered in this checkup, but the checkup may provide other helpful information. If homeowners are interested, they can call (352)518-0156 to request their individual checkup.
- **3.** Clubhouse Outdoor Cameras Burned Out Jill reported that two clubhouse cameras have burned out Four new cameras have been purchased to replace them. Currently there are problems with getting them to connect to the internet, so a wifi extender is being looked into to fix that problem.
- **4.** Landscaping For Entry Sign On Left Side, First **Proposal Too High** We don't own that sign, so we will focus on low cost alternatives for sign landscaping.

#### **Social Club Update & Call For Volunteers:**

Jill reported that the **Veteran's Day** event is Tuesday, November 11<sup>th</sup> at 11:00 AM, and tickets are \$10. Judith is the speaker, and Bob Krobatsch is being honored at this event.

**Movie night** is October 31, and will be a halloween movie. The next movie night after that will be Friday, November 28, at 7:00 PM.

The **Christmas party** will be on Saturday, December 6, at 5:00 PM. Tickets are \$20 per person, catered by Slice Of Life. True Passion will provide the entertainment. Setup will take place on December 4<sup>th</sup>, following the Social Club breakfast, and volunteers are needed and welcome.

The **November Social Club** breakfast is November 6<sup>th</sup>, at 8:00 AM.

### HUNT RIDGE HOMEOWNERS' ASSOCIATION BOARD MEETING MINUTES October 20, 2025

#### Call to Order

The board meeting was called to order at 7:01 pm by Nick Vavoulis – President. Board members present: Anne McQuade -Vice-President, Trish Ives - Secretary, Patrycja Zajac – Treasurer, Susan Gavin, and Saile Alvarez from Parklane RES. A quorum was established.

The Meeting **notice** was posted at the Tall Pines Clubhouse and on signs throughout the community.

#### Approve Minutes - Previous Board Meeting

A motion to waive the reading of the minutes from the last meeting and approve, as posted on the website, was made by Susan, seconded by Anne; motion carried.

#### **Treasurer's Report**

Financials were reviewed by Patrycja Zajac. Total revenue year-to-date is \$146,120.93; Total operating expenses were \$163,963. There is a deficit of \$17,842.51 and Accounts Receivable are \$9293.74. Susan Gavin noted that the A/R is mostly attributable to the new resident payment system.

#### **Management Report**

Parklane RES reports no new major violations at this time. Parklane RES continued to work with attorneys on past-due HOA violations. Saile Alvarez asked if Hunt Ridge wants to proceed with creation of a Hunt Ridge website, and the board confirmed the previous decision to move forward. Parklane RES has not been able to obtain any sidewalk cleaning quotes, but they will continue to pursue quotes before the next Hunt Ridge budget meeting.

#### **Old Business**

The resident mailbox at 7437 Baltusrol Drive is still pending repair & relocation. Nick Vavoulis said the resident is waiting for the new bracket to arrive.

#### **New Business**

#### **Authority to Fine**

Susan Gavin presented information from our new property management company (Parklane RES) that clarifies our violation policy. The ability to levy fines is not supported by our documents, therefore we shall rely on the Abatement process as outlined in Article IX, section 7 of the Declaration of Covenants, Conditions and Restrictions. In the case of non-compliance, the association shall cure the violation and bill the homeowner for the expense.

Susan Gavin made a motion to remove any fines currently on a homeowner's ledger and disband the compliance committee. We thank them for their past participation. Nick Vavoulis seconded the motion; motion carried.

#### **Resident Petitions**

Susan Gavin restated requirements for homeowner peti-

#### tions:

Susan Gavin restated requirements for homeowner petitions:

2/3 of the community – 93 votes – are required to pass amendments to change use restrictions as outlined in the Declaration of Covenants, Conditions and Restrictions.

→ After board receipt of petition signed by 20% of total voting interests, a Special Meeting will be held and all homeowners will have the opportunity to voice their opinions. Pending the outcome of the meeting, our attorney will prepare the amendment, and each homeowner will have the opportunity to submit an official vote.

#### 2026 Budget Planning

No new budget items were presented.

#### **Tall Pines Common Areas**

The board discussed maintenance of the sidewalks and common areas around the Hunt Ridge community. Thus far, Tall Pines has refused several requests from Hunt Ridge's HOA board for sidewalk pressure washing. Saile Alvarez with Parklane RES will check with Richard Bremer at Parklane about options the board may pursue with Tall Pines on this matter.

#### **Open Forum**

Susan Gavin made a motion to foreclose on the property at 10318 Ravines for past-due HOA fees; Patrycja Zajac seconded the motion; the board unanimously approved. Susan Gavin proposed a financial change for our HOA reserve account. The current Savings account will be closed and funds moved to the Operating account. Anne McQuade seconded the motion, and it was unanimously approved.

A homeowner attending the meeting asked for a list of homeowners in the community so they can petition the residents. Saile Alvarez will check to see if a list can be provided.

Susan Gavin asked Saile Alvarez if Parklane RES could assist with new homeowner information (i.e., printed packets or a website). Saile Alvarez will look into what the property management company can do to assist.

**Next Meeting Date** The next meeting is scheduled for Monday, November 17, 2025, at 7 PM, Tall Pines Clubhouse.
