1. Article VI of Articles of Incorporation of Valley Wood, is amended to read as follows:

Class A. Class A members shall be all owners, with the exception of the Declarant. All Owners shall be members and shall be entitled to one (1) vote for each Lot owned. When more than one (1) person holds an interest in any Lot, all such persons may be members. The vote for such Lot shall be exercised as they determine, but in no event shall more than one (1) vote be cast with respect to any Lot.

Substantial rewording. See governing documents for current text. Class B(a) – (c) will be deleted in its entirety.

2. Article VII of Articles of Incorporation of Valley Wood, is amended to read as follows:

The affairs of this Association shall be managed by a Board of Directors initially composed of four (4) Directors, who need not must be members of the Association, but shall never be less than three (3) nor more than (9). The Directors shall be divided into three (3) classes: Class A, Class B, and Class C. The term of office for all Directors shall be three (3) years, except that the term of office of the initial Class A Director one-third (1/3) of the Directors shall expire at the first annual meeting of the members, the term office of the initial Class B Director another one third (1/3) of the Directors shall expire at the annual meeting one (1) year thereafter, and the term of office of the initial Class C Directors remaining one third (1/3) of the Directors shall expire at the annual meeting two (2) years thereafter. At no point shall a majority of the Board of Directors be up for election in one year. The names and addresses of the persons who are to act in the capacity of Directors until their successors are elected and qualify unless they sooner shall die, resign, or are removed are:

## ARTICLE XI DISSOLUTION

The Association may be dissolved with the assent given in writing and signed by not less than two-thirds (2/3) of each class of member the members. Upon dissolution of the Association, other than incident to a merger or consolidation, the assets of the Association shall be dedicated to an appropriate public agency to be used for purposes similar to those for which this Association was created. On the event that such dedication is effused acceptance, such assets shall be granted, conveyed and assigned to any non-profit corporation, association, trust or other organization to be devoted to such similar purposes.

5. Article XIII of the Articles of Incorporation of Valley Wood, is amended to read as follows:
