#### **COMMUNITY NOTES**

- **1. The Board is asking residents to report any incidents of concern in the community.** Some recent examples involve trees, dogs, landscaping neglect, trash problems.
- **2. Please remember that your first 2023-2024 HOA payment, due for March, is \$191.** If you signed up for autopay on the **3rd of the month**, through our HOA, your payment will automatically be increased. If you arrange payment yourself with your bank, be sure to change your payment. If you mail in a check, also be sure to send the new amount. Try to have payments arrive early in the month due, and not in the previous month, i.e., this time, February, if possible. This simplifies our accounting process.
- **3.** Check with Jill Bell if you need a handyman, plumber, dog walker or someone to check your mail or villa. We have people in our community that can assist you.
- 4. For any sprinkler system issues call Ameri-tech's Andrew George at 727-726-8000 Ext. 301
- **5.** IF YOU PLANT OR MULCH IT YOU MUST MAINTAIN IT according to ARC documents. Refresh your mulch, maintain your plants. Remove your weeds.
- 6. No plantings other than trees are to be over our 7 feet tall limit. Please trim accordingly.
- 7. No plants are allowed to grow on villa, sheds, carport, columns roofs, etc!

- Reserves: Roof \$134,819; Paint \$49,411; General \$110,622; Total Reserve \$294,852
- Total Operating & Reserve Funds \$342,157
