Welcome to a new Valley Wood publication!

At their December HOA Meeting, the Tall Pines Board of Directors announced through their management company, Ameri-tech, that all communities were to submit their monthly HOA meeting Minutes to a new website, www.tallpinesnpr.com.

This new website is being managed by Ameri-tech. Since the Hi Lites will no longer be printed, meeting Minutes from Hunt Ridge, Ruxton Village, Ruxton II, Spring Lake and Valley Wood will no longer be hand-delivered to community owners to read. The only way to see all the Minutes now, is to go on-line to the new website, or to go to the Clubhouse and see one posted for viewing.

#### **SECRETARY REPORT:**

Sue Mac Queen reported that November minutes were published in the Hi Lites. Motion to waive the reading and accept as published, by Jill. Second by Cathy. All in favor 4/4, motion passed.

#### TREASURER REPORT for NOVEMBER 2021:

Monthly Income is \$16,201. Monthly expenses are \$14,152 for a Surplus of \$2051.

Year to Date Income: \$134,407. YTD Expenses \$130,745 for a Surplus of \$3,662.

#### **OLD BUSINESS:**

**POND**: The TP board approved an expenditure for Pristine Ponds to install 400 plants after frost danger, around the east end of the pond in an attempt to stabilize the soil.

**ROOF LEAKS**: One on Bayhill Ct has been repaired and the \$975 invoice paid. Bids have been approved for 10700 and 10814 LaQuinta.

**RENTAL UNIT LIMITATION LIMITATION AMMENDMENT**: In process. A page for voting on this will be in the January mail package.

**TALL PINES BUDGET**: There is no dues increase to Tall Pines. Each owner will continue to owe \$52.40 for the 2022-2023 Fiscal Year.

#### OLD BUSINESS, CONTINUED

**GREEN THUMB 2022-2023 BUDGET**: The Board may extend the weekly mowing through October. No use of Round-Up, and bi-weekly edging will continue.

**MAILBOXES IN POOR CONDITION**: Two mailboxes are reported to be in poor condition. With sharp edges, rust and water leaking. USPS needs to be contacted.

#### **NEW BUSINESS**

**LATE FEES**: In November, Parklane started charging late fees on delinquent HOA payments. The Board was not aware of this, until the financials were reviewed, and will follow up with them.
